

## **Everett Public Library Chromebook/Hotspot Lending Agreement**

The Everett Public Library makes Chromebooks and Hotspots available for patron use. Chromebooks have Wi-Fi capability. Additionally, the library lends mobile Wi-Fi Hotspots that connect to cellular networks so that users can connect devices (Chromebooks, laptops, phones, etc.) to the internet.

### **ELIGIBILITY**

- The borrower must have a current Everett Public Library account in good standing.
- Chromebooks and Hotspots are available for adults and individuals under 18 years old with a parent/guardian signature.

### **LOAN PERIOD/AVAILABILITY**

- Chromebooks and Hotspots may be checked out for 3 weeks.
- They may be renewed up to two times if no one is on the waitlist.
- Hotspots will be disabled after 1 day of being overdue.

### **DISCLAIMER**

- The Library is not responsible for any lost or corrupted files or for damage to any personal technology, computers, storage media or equipment.
- The Library is not responsible for compromised information or data due to network security or due to any other reason.
- I understand that I use the Chromebook and Hotspot at my own risk.

### **FINES AND LIABILITY**

- The Library's Computing, Damaged Material, and Loan Policies apply to Chromebook and Hotspot use.
- The borrower or parent/guardian is financially responsible for any damage or loss that occurs during the checkout period.
- The borrower must return the device and all components to a Library staff member during Library business hours.
- I agree that Everett Public Library and the City of Everett is not liable for any damages that may occur because of any loss of data or files, any disclosure or loss of confidential information, any unauthorized access to or alteration of data transmissions, or any other direct, indirect, special, incidental, consequential or exemplary damages relating to or arising from of my use of the Chromebook and/or Hotspot.
